New Project Funding Opportunities

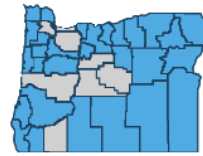
DV Bonus

- ▶ **\$483,828** of Domestic Violence Specific funding available
 - ▶ One, but no more than three programs
- ▶ Types of projects that can be funded:
 - ▶ Rapid Rehousing
 - ▶ Permanent Supportive Housing
 - ▶ Supportive Service Only for Coordinated Entry
 - ▶ Expansion of an existing renewal project to dedicate additional beds and services to the DV population.

New Projects

- ▶ **\$161,276** of new funding available
- ▶ Types of projects that can be funded
 - ▶ Permanent Supportive Housing
 - ▶ Rapid Rehousing
 - ▶ Joint Transitional Housing and Permanent Housing – Rapid Rehousing Components

Rural Oregon Continuum of Care (ROCC) / OR-505 (Oregon Balance of State CoC)

August 24th, 2021

On August 18th, 2021, HUD published the Notice of Funding Opportunity (NOFO) for the Fiscal Year (FY) 2021 Continuum of Care (CoC) Program Competition: ROCC has opportunity to submit one or more applications totaling no more than \$161,276 in new/bonus project funding in this competition¹ and an additional opportunity to submit one but not more than three (3) applications totaling no more than \$483,828 specific to projects serving DV population.

All potential renewal and new project applicants must follow process and procedure outlined in the document titled '2021 OR-505 BOS CoC HOW TO APPLY' including submission of all documents outlined in Section 3/Page 1 of 7. Deadline to submit application packets is **close of business Thursday, September 30, 2021.**

Note that the DRAFT application will be created in HUD's electronic application submission tool, *e-snaps*; potential applicants not already registered in e-snaps should do so straightaway. Selection through the local pre-application process does not guarantee the project will be awarded funding, only that it will be forwarded to HUD in a national competitive application for funding.

Eligible project applicants for this funding include non-profit organizations, states, local governments, instrumentalities of state and local governments, and public housing agencies; for-

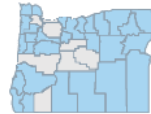

1.0 INTRODUCTION

The primary purpose of the ROCC-required CoC internal application process is to provide an in-depth look at the ROCC's many projects for completing the Review and Ranking process (R&R) and provide advice to ROCC Leadership/R&R Team in prioritizing both renewal and new/reallocated projects in the annual HUD CoC funding competition's Tier 1 and Tier 2 divisions.

All potential project applicants – new or existing – must be registered in HUD's e-snaps internet-based data reporting/application system with active profiles and authorized representatives prior to beginning competition process.

The CoC's internal application process will NOT begin until approximately one week after HUD NOFO release when blank project applications are available in e-snaps. Upon successful completion of the R&R process, applicants approved for project submission in the CoC's Priority Listing will be given clearance to 'submit' in e-snaps.

2.0 DEADLINE AND SUBMISSION CONTACT

The application packet(s) relevant to your anticipated projects (including required attachments) must be submitted via email to the CoC at oregonbos@gmail.com no later than close of business, **Thursday, September 30th, 2021.**

- *INCOMPLETE SUBMISSIONS WILL NOT BE ACCEPTED PAST THE DEADLINE UNLESS EXTREME NEED EXISTS AND REQUEST HAS BEEN MADE AND APPROVED PRIOR TO DEADLINE.*

Why is Tiering Important?

- ▶ Grantee Competition
 - ▶ Application we are discussing today
- ▶ Continuum of Care Competition
 - ▶ Bonus funding is non-guaranteed
 - ▶ We rate and rank, send list with our narrative application, ranked against other CoCs
 - ▶ Our CoC score is what is used to determine final funding amounts

- Submit NOFO application “packets” to oregonbos@gmail.com
 - Include all necessary supplemental information

9/30/21 –
10/11/21

- Applications are scored and ranked by Review and Ranking Committee
- Score and rank are shared with all submitters
 - Option of appealing decision
 - Due 10/29

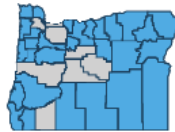
10/11/21 –

- Final review of application in esnaps
- Attend ROCC quarterly meeting for priority listing discussion
 - Wednesday, October 20th
- Final submission in Esnaps

- ▶ All project proposal packets due
 - ▶ Thursday, September 30th
- ▶ First notification of application score and ranking
 - ▶ Monday, October 11th
